- 1.) All plates have a prorated \$76.50 purchase fee and a \$66.50 renewal fee for each following year. All fees must be submitted with this application.
- 2.) Specialized plates are only issued for CLASS A vehicles, or passenger vehicles under 10,001 pounds gross vehicle weight.
- 3.) When you receive your new plate, your old plate and registration form must be returned to the DMV within 10 business days.
- 4.) This application and check or money order payable to WV DMV can be taken to your nearest DMV regional office or mailed to the address on the top of this form.
