## **PART III • Instructions for Applicant**

- 1.) Complete Part I of this form. Only one vehicle can be certified per form. Only qualified vehicles may/can be used as an implement of husbandry, which if not required for farm use, would be required to be registered as a Class A (pick-up truck under 10,000 lbs) or a Class B (truck, tractor-trailer combinations 10,001lbs and over). These vehicles are required to have the words "FARM USE" affixed to both sides of the vehicle in ten inch letters in addition to displaying a "FARM USE" sticker on the windshield. These vehicles are still subject to the restricted use of provision of WV Code §17A-3-2.
- 2.) Submit the application to the Assessor of your County of residence along with a fee of \$2.00 made payable to the County Assessor.
- **3.)** After the Assessor completes and approves the application, the Assessor will issue a FARM USE Exemption decal for each qualified vehicle, as well as a copy of the completed application(s).
- 4.) You must affix the FARM USE vehicle decal to the inside lower driver side corner of the windshield.
- 5.) Be sure to retain the copy of the application for your records.
