<u>Question 1:</u> Line one is asking for 72,800 lbs of 4"x4"x1/2" Steel Angle x 20" long which I can quote these cut to length no problem but I figured maybe it was a typo and you needed 20' pieces.

**<u>Response 1</u>**: Yes, it was a typo. We need 20' pieces.

Question 2: I will be bidding on your RFQ for the steel angle. I know I missed the RFI deadline, but just noticed on LINE 2 that you are calling for 2" x 2' x 3/16" x 20' steel angle. Is this a typo and should be 2" x 2" stock angle? Or are you actually looking to have steel plate fabricated/bent to 2" x 2' (feet and not inches)?

Response 2: Yes, it is a typo. We need 2" X 2"
