**Effective until 11/24/2017, the Downtown Weirton WV-2 on ramp onto US-22 EB is closed.**

**Effective 11/8/2017 through 11/17/2017, Doddridge C11 will be closed .5 miles north of US-50.**

**C3 – HARRISON COUNTY – 15' width restriction at MP 8.17.**

**C7 – MARSHALL COUNTY – Effective 8/15/2016, road will be closed for slip repair from C5 to C46.**

**C8 – MINGO COUNTY – Closed because of flood damage.**

**C9/1 – KANAWHA COUNTY – 10' width restriction (both ways, Coal River Road).**

**C11 – DODDRIDGE COUNTY – Effective 11/8/2017 through 11/17/2017, closed .5 miles north of US-50.**

**C11 – MARION COUNTY – Effective 10/30/2017 through 11/10/2017, closed 0.01 miles south of the junction with C48.**

**C14 – LOGAN COUNTY – 12' width restriction (both ways).**

**C21 – BRAXTON COUNTY - Closed at MP 0.40 from 7:00 a.m. to 5:00 p.m. for slip repair.**

**C24 – CABELL COUNTY – MP 0.00 to 1.04 closed, as of April 26, 2010 for Merrick Creek Bridge replacement. Bypass is C19 (Little Seven Mile) and WV193 (Merrick Creek Connector). Expected duration of closure four weeks.**

**C35 – TUCKER COUNTY – Closed, effective September 29, 2011.**

**C38 – BERKELEY COUNTY – Effective 11/8/2017 through 11/10/2017, closed for railroad work.**

**C39/18 – NICHOLAS COUNTY – Closed 0.03 miles from intersection with WV-39 to intersection with C39/25.**

**C45 – MONONGALIA – Effective 10/17/2017, closed from MP 11.50 (junction with C19/19) to MP 12.77 (River Ridge Estates).**

**C46 – KANAWHA COUNTY – Closed to all OS and/or OW loads.**

**C54 – MARSHALL COUNTY – Effective 11/8/2017 through 11/24/2017, closed at MP 1.30 for slip repair.**

**C54 – MARSHALL COUNTY – Closed at MP 2.73.**

**C62/2 – MARSHALL COUNTY – Closed.**

**C82 – FAYETTE COUNTY – Closed from intersection with C85/3 to MP 4.61.**

**C89 – WETZEL COUNTY – 12’ width restriction at MP 15.44.**

**I-64 – CABELL COUNTY – Nothing more than 15’ high, 11’ wide, and/or 95’ long allowed from MP 7.20 to 20.19 (both directions) from 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 p.m. daily.**

**I-64 – CABELL COUNTY – 22’ width restriction from MP 11.00 to 15.00 (both directions) from 5 a.m. to 7 p.m., effective 4/8/2013 AND 11’ width restriction (both directions) after 7 p.m.**

**I-64 – GREENBRIER COUNTY – 19’ width restriction from MP 150.00 to 151.00 (both directions).**

**I-79 – BRAXTON COUNTY – 13’ 6” width restriction at MP 51.47 (both directions).**

**I-79 – BRAXTON COUNTY – 13’ 6” width restriction at MP 54.18 (both directions).**

**US-19 – FAYETTE COUNTY – 12’ width restriction from MP 5.74 to 9.19 (both directions).**

**US-19 – FAYETTE COUNTY – Effective 4/4/2017, 17’ 6” width restriction from MP 18.50 to 21.00 (New River Gorge Bridge), in both directions.**

**US-19 – HARRISON COUNTY – Bridge at MP 25.79 is limited to 80,000 lbs. GVW for all southbound traffic.**

**US-22 – BROOKE COUNTY – Effective 10/19/2017 through 11/10/2017, 12’ width restriction at WV-2 exit ramp (Exit 2), eastbound only.**

**US-33 – PENDLETON COUNTY – 12’ width restriction at MP 37.52.**

**US 40 – analysis required on ALL LOADS for weight – NOTHING MORE THAN 12 wide or 75 long – EVEN IF WEIGHT IS NOT A FACTOR - (d-6)**

**US-50 – RITCHIE COUNTY – Effective 3/13/2017, 16’ width restriction at MP 10.01 (eastbound).**

**US-50 – RITCHIE COUNTY – 16’ width restriction at MP 12.85, westbound only.**

**US-119 – ROANE COUNTY – 13’ width restriction from MP 19.49 to 20.84.**

**US-220 – HARDY COUNTY – 11’ 6” width restriction at MP 17.85.**

**US-250 – WETZEL COUNTY – 12’ width restriction at MP 7.97.**

**US 522 - ALL LOADS ON US 522 GREATER THAN 15 FEET WIDE NO TRAVEL ON FRIDAY AFTERNOONS (d-5)**

**WV-2 – BROOKE COUNTY – Effective until 11/24/2017, the on ramp from WV-2 in downtown Weirton to US-22 EB will be closed.**

**WV-2 – OHIO COUNTY – 12’ width restriction at various locations from MP 5.44 to 7.17.**

**WV-5 – GILMER COUNTY – Effective 4/1/2015, there will be a 10’ width restriction at MP 2.15.**

**WV-10 – CABELL COUNTY – Effective 7/17/2015, Hal Greer Boulevard will be closed at its junction with 8<sup>th</sup> Avenue in Huntington.**

**WV-41 – FAYETTE COUNTY – 10’ width restriction from MP 6.50 to 7.00.**

**WV-61N – KANAWHA COUNTY – 12’ width restriction on southbound lanes of Admiral T.J. Lopez Bridge, over the Kanawha River in Chelyan, effective 5/13/2013.**

**WV-62 – KANAWHA COUNTY – Closed from MP 0.31 to 0.81.**

**WV-62 – MASON COUNTY - 12’ width restriction at the 10 Mile Creek Bridge.**

**WV-65 – MINGO COUNTY – Effective 11/11/2017 only, closed at MP 22.60 (approximately 1.1 miles south of the intersection with US-52,**

**WV-82 – WEBSTER COUNTY – Effective 4/28/2016, 15’ width restriction at MP 6.65.**

**WV-86 – MARSHALL COUNTY –WARNING: THIS IS A DANGEROUS, NARROW ROAD THAT LARGE LOADS SHOULD AVOID WHEN POSSIBLE.**

**WV-88 – OHIO COUNTY – Effective 9/25/2017 through 11/17/2017, 10’ width restriction from MP 6.18 to 7.16.**

**WV-152 – WAYNE COUNTY – 11’ 3” width restriction at MP 23.71.**
