FFY 2019-2021 DBE GOAL SETTING

In accordance with the requirements of the U. S. Department of Transportation as set forth in 49 C.F.R. Part 26, as amended, the West Virginia Department of Transportation, Division of Public Transit (the Division), hereby notifies the public that its FFY 2019-2021 FTA Disadvantaged Business Enterprise (DBE) goal for procurements with small business concerns owned and controlled by socially and economically disadvantaged individuals (DBEs) is currently in development. The U.S. DOT's rule requires development of a three-year DBE goal and methodology.

The Division invites the public to offer their comments, concerns or input in the overall goal-setting process prior to publishing the goal on July 1, 2018.

EARLY PLANNING

This notice shall serve as early notification to all private transportation providers and the general public that organizations eligible under the 49 U.S.C. Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program and 49 U.S.C. Section 5311 Formula Grants for Rural Areas Program, are presently reviewing their transportation needs and/or services.

According to federal planning requirements, private providers and the general public [including low-income, minority and Limited English Proficiency (LEP) persons and groups that represent them] are entitled and encouraged to participate in the early planning and project development of these services. Please note, if a translator is needed, please notify the Division. It is imperative that your participation begin immediately to allow your comments to be considered when these applications for potential funding are being developed. Comments will be accepted until March 30, 2019.

This notice does not apply to transit authorities in urbanized or TMA areas that receive Section 5307 funding (i.e., Eastern Panhandle Transit Authority-Martinsburg; Kanawha Valley Regional Transportation Authority-Charleston; Tri-State Transit Authority-Huntington; Mid-Ohio Valley Transit Authority-Parkersburg; Monongalia County Urban Mass Transit Authority-Morgantown; Ohio Valley Regional Transportation Authority-Wheeling; New River Transit Authority-Beckley; and, Weirton Transit Corporation-Weirton). The area metropolitan planning organization and/or the transit authority may publish separate public notices locally.

PUBLIC NOTICE INTERCITY BUS

Notice is hereby given that the West Virginia Department of Transportation, Division of Public Transit has a percentage of its annual 49 U.S.C. Section 5311 apportionment set aside to administer a program for the development and support of intercity bus transportation. The primary objective of the program is to provide support services to meet the intercity travel needs of non-urbanized area residents.

In an effort to develop an intercity bus program to meet these program objectives, the Division is soliciting input from interested groups. Comments regarding this program will be accepted until March 30, 2019. In the absence of any public input or if no projects are identified as a result of the consultation process, the State will file a Governor's Certification with the Federal Transit Administration which will attest that the Intercity Bus needs of the State of West Virginia are being adequately met, "relative to other rural needs in the state".
