Instructions

1. To qualify for a special military plate, the applicant must have a current special military plate of the same type on an existing vehicle titled in the applicant's name.
2. The vehicle upon which the second special military plate will be placed, must be currently titled in West Virginia in the name of the applicant. The vehicle must be a **Class A** car or truck and may not be used for commercial purposes.
3. When you receive your new second special military license plate, the currently assigned plate and registration card must be returned to the DMV within ten days.
4. Second special military license plates expire July 1st. An annual \$10.00 reservation fee is required in addition to the **\$51.50 annual registration fee**. See the chart on the right to calculate your initial plate fees.
5. Mail your completed application, check or money order, and your personal property tax receipt or affidavit from the Assessor if your registration is expiring within 60 days to:

How to Calculate Your Fee

If you are exchanging a **VALID** license plate, use the first character of your plate, or for veterans plates, use the small number under the "V". Add a \$10.00 reservation fee, a \$5.00 transfer fee, and a .50¢ insurance fee to the total.

If you don't have a valid license plate use the current month on the table to find your fee, and add the \$10.00 reservation fee to the total.
