**COMPLETE OR TYPE THIS APPLICATION IN BLUE OR BLACK INK.  
DO NOT USE THIS APPLICATION FOR CLASS "V" PLATES.**

- 1. Complete section A, Owner(s) Information.** Be sure to list the name(s) exactly as shown on current registration that you wish to register the antique plate.
- 2. Complete section B, Insurance Information.**
- 3. Complete section C, Vehicle Information.** This application can only be used for vehicles older than 25 years.
- 4. Complete section D for the addition of antique fleet vehicles.** This application is for the use of Antique Fleet Registration.

The Antique Fleet Plate must meet the following requirements:

- If you have an existing fleet and wish to add more vehicles, please complete this application listing your existing license plate information in section D and section C with your additional vehicles.
- Pursuant to WV Code §17A-10-3A, the West Virginia Division of Motor Vehicles has developed an Antique Fleet Program to allow anyone who owns five (5) or more Antique Motor Vehicles to register and use a single license plate on the vehicles. One registration plate will be issued and an individual registration card will be issued for each vehicle.
- The Antique Fleet Plate is considered restricted use such as participation in club activities, exhibits, tours, parades, and similar events.
- The license fee for this plate is \$2.00 per vehicle per year and will be renewed annually.
- All Antique Vehicle plates expire July 1<sup>st</sup>.
