## Instructions for Completing the Form: Application for the Use of an Antique Military Registration

- **1. Complete section A, Owner(s) Information**. Be sure to list the name(s) exactly as shown on current registration that you wish to register the unique military identification markings.
- 2. Complete section B, Vehicle Information. This application can only be used on a military vehicle older than 25 years.
- 3. Complete section C, Insurance Information.
- **4. Restriced Use, Original Military Markings that are Unique to the Vehicle.** Vehicle is to be used for limited purposes such as club activities, exhibits, tours and similar events, or for recreational purposes on Saturdays, Sundays, and holidays.
- **5. Complete section D, Antique Registration Information.** The antique military identification markings must meet the following requirements:
  - The unique identifying markings cannot exceed eight (8) characters and cannot contain special characters or symbols. Place the characters in the boxes exactly as they appear on the vehicle. Please clarify any alpha numeric combinations that can be confusing (e.g., 6 or G, 2 or Z, 1 or I, 5 or S, 0 or O).
  - The military identification markings must be unique and original to the vehicle. If more than one request is made for the same military identification number, DMV shall only accept the first application.
  - A clear color photograph of the military identification markings must be provided with this application.
  - For a registration approved with for a vehicle with unique identifying military markings, you will not have a decal. A registration card will be issued to you indicating the expiration date and plate number assigned to the vehicle.
  - All antique vehicle registrations expire July 1st. Restricted use registrations function on a 10 year cycle. When the current cycle ends on July 1, 2025, your Antique Military Registration expires.
- **6. Complete section F, Applicant Certification.** Sign and date this form to finalize your request.
- 7. Enclose the correct fee with personal property tax ticket if the current license plate is expiring. See the chart below for *restricted use* fees. An additional special annual fee of \$40.00 for Antique Military Registration with vehicle original markings, as per §17A-10-3a(f), is included.
