Current license plate must be returned to the Division of Motor Vehicles after the special plate is received. After issuance of the special plate, the exchanged plate is canceled and cannot be transferred to another vehicle. There are no refunds.

The vehicle must have a West Virginia title and license plate in the name of the applicant before a special plate can be issued.
