## **Instructions & Information**

- In order for a vehicle to be eligible for this plate class, it must meet the following criteria:
  - The type of vehicle must be CLASS A (passenger car or truck).
  - The vehicle must currently be titled in West Virginia, in the applicant's name.
  - Leased vehicles are only eligible if the qualified applicant's name is listed on the title.
- If you wish to register this plate with a new vehicle, it is more convenient for you to title and register your new vehicle with a regular plate first, due to the time required for processing and production time of these plates.
- If you wish to have a personalized plate, please observe the following guidelines:
  - •You may indicate up to four selections, in order of preference under **Section E** on the reverse side of this form.
  - Personalized selections can have a minimum of two characters or a maximum of eight.
  - Symbols and punctuation cannot be used.
  - Place all characters exactly as you wish for them to appear on the plate, all characters will be centered unless you specify otherwise.
  - Be sure to clarify alpha and numerical characters that can be confusing (i.e. 1 or I).
  - Your first selection available will be produced.
- There are no restrictions on the number of special license plates you may obtain, however your name must be on the title as either owner or lessee.
- PART II is to be completed by the Senate or House Clerk. Please send this application and correct fees payable to WV Division of Motor Vehicles (use table below to calculate the fees due), to either the House Clerks Office or the Senate Clerks Office. They will certify the application and will forward both application and check onto the DMV to compete your request.
