A MANDATORY PRE-BID meeting will be held July 13, 2020 at 9:30 am virtually or at the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306. Attendees must be full time employees of the Contractor.

This contract is located in Raleigh County. This project consists of removing the existing EPDM roofing and underlying insulation to expose the existing built-up roof and install new insulation and EPDM roof.

The estimated roofing area is as follows:

3,072 Square Feet for each Canopy roof (Northbound and Southbound)

All work under this contract shall not begin prior to September 9, 2020 and be completed by **October 30th, 2020.**

Proposals will be received via Bid Express until **3:00 PM July 30, 2020** at which time said proposals will be publicly opened and read virtually or at the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306. No bids will be received after the scheduled opening.

Proposals must be made via Bid Express in the manner designated in the specifications, and must be accompanied by a CASHIER'S or CERTIFIED CHECK or BID BOND in favor of the West Virginia Parkways Authority, FOR AN AMOUNT EQUAL TO FIVE PERCENT (5%) OF THE AMOUNT OF THE PROPOSAL OR \$2,000 WHICHEVER IS THE GREATER, and must be delivered to the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306 on or before the day and hour named. Bid bonds may instead be submitted electronically via Bid Express. ANY BID THAT IS NOT ACCOMPANIED BY A BID BOND DELIVERED ELECTRONICALLY VIA BID EXPRESS OR A CASHIER'S CHECK, A CERTIFIED CHECK, OR A BID BOND DELIVERED AT THE PLACE DESIGNATED ABOVE ON OR BEFORE THE DAY AND HOUR NAMED WILL BE CONSIDERED IRREGULAR.

All bids submitted by bidders who have been debarred or declared ineligible by the Director of the Purchasing Division shall be rejected.
