This Contract consists of demolition of existing Travel Plaza facilities and construction of new Travel Plaza facilities at the Beckley and Bluestone sites. This includes buildings, parking lots, fueling, and site lighting.

A MANDATORY PRE-BID meeting and site review will be held 1/20/2023 at 9:00 am at the Tamarack Conference Center in Beckley, WV. Participants must attend in-person and be full time employees of the Contractor to be allowed to bid on the project.

All work under this contract shall be completed by **October 31, 2024**.

Proposals will be received via Bid Express until **3:00 PM February 16, 2023** at which time said proposals will be publicly opened and read at the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306. Proposals must be made via Bid Express in the manner designated in the specifications, and must be accompanied by a CASHIER'S or CERTIFIED CHECK or BID BOND in favor of the West Virginia Parkways Authority, FOR AN AMOUNT EQUAL TO FIVE PERCENT (5%) OF THE AMOUNT OF THE PROPOSAL OR \$2,000 WHICHEVER IS THE GREATER, and must be delivered to the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306 on or before the day and hour named. Bid bonds may instead be submitted electronically via Bid Express.
