**This contract is located in Kanawha County. It consists of milling approximately 22,400 total square feet of existing epoxy aggregate overlay off the existing bridge deck and applying a new Protective Bridge Deck Overlay.**

Proposals will be received via Bid Express until **3:00 PM July 12, 2022** at which time said proposals will be publicly opened and read at the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306. Prospective bidders must be prequalified in accordance with SECTION 102.1 of the WVDOH Standard Specifications. Proposals must be made via Bid Express in the manner designated in the specifications, and must be accompanied by a CASHIER'S or CERTIFIED CHECK or BID BOND in favor of the West Virginia Parkways Authority, FOR AN AMOUNT EQUAL TO FIVE PERCENT (5%) OF THE AMOUNT OF THE PROPOSAL OR \$2,000 WHICHEVER IS THE GREATER, and must be delivered to the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306 on or before the day and hour named.
