This project is located along the West Virginia Turnpike at I-77 Milepost 16.93. It consists of fully replacing the southbound bridge deck over Mercer County Route 3 with precast deck panels and barriers utilizing accelerated bridge construction.

Prospective bidders must be prequalified in accordance with SECTION 102.1 of the WVDOH Standard Specifications.
