This contract is located in Raleigh County. This project consists of removing the existing EPDM roofing and underlying insulation to expose the existing built-up roof and install new insulation and EPDM roof.

The estimated roofing area is as follows:

1,536 Square Feet for each Canopy roof (Northbound and Southbound)

All work under this contract shall not begin prior to September 8, 2021 and be completed by **October 29<sup>th</sup>, 2021.**
