Proposals will be received via Bid Express until **3:00 PM January 21, 2021** at which time said proposals will be publicly opened and read virtually or at the office of the West Virginia Parkways Authority, Administration Building, 3310 Piedmont Road, Charleston, West Virginia 25306. No bids will be received after the scheduled opening.

Bid bonds may instead be submitted electronically via Bid Express.
