

## WVDOH Working Around the Clock in Wake of Devastating Ohio County Floods

West Virginia Division of Highways (WVDOH) work crews have been working around the clock to open roads and clear debris after up to four inches of rain fell in Ohio County during a half-hour period on Saturday, June 14, 2025. Flash flooding killed at least three people and destroyed numerous homes in the Wheeling area.

"Our thoughts are with those affected by this fast moving storm," said Transportation Secretary Stephen Todd Rumbaugh, P.E." I have deployed resources from several DOH districts to assist with equipment and operators and will continue on the scene until it's complete."

Rumbaugh deployed resources from WVDOH districts 1, 2, 3, and 4 to assist District 6 crews with cleanup efforts, including 29 pieces of heavy equipment and their crews.

WVDOH District 6 Manager Mike Daley said he had not seen such devastation since the historic floods of 1985 and 2016.

"It blew the windows and doors out of houses," Daley said. "It washed homes off of their foundations and carried mobile homes 200 or 300 feet from their original locations."

Four roads in Ohio County, including a section of US 40, remain closed daily from 7 a.m. to 7 p.m. for flood repairs, although local traffic and emergency vehicles are being accommodated. G. C. & P. Road remains closed to all traffic, while Dixons Run Road is accessible to emergency vehicles only.

WVDOH cleanup crews dealt with massive debris choking the roads, including cars, buildings, and even homes that were swept up by floodwaters.

Numerous bridges were also choked with debris, including Conex storage containers and cars.

WVDOH work crews worked with state and local officials and emergency responders to get access to people still trapped by the flooding.

### DRIVE SAFE: SECURE YOUR LOAD

The West Virginia Governor's Highway Safety Program (GHSP) is teaming up the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA), to remind drivers to Drive Safe: Secure Your Load. It is every driver's responsibility to ensure all cargo is safely secured. Items not properly secured pose a safety risk on our nation's roadways.

Every U.S. state has a law making it illegal for a driver to operate a non-commercial motor vehicle with an unsecured load. Violating these laws can carry state-specific penalties of up to \$5,000. Objects or debris can fall from vehicles and collide with other vehicles or pedestrians, causing serious injuries or fatalities. For this reason, it is essential for drivers to properly secure their load.

National Secure Your Load Day in West Virginia was celebrated on Tuesday, June 6, 2025. This day, which began in 2004, aims to raise awareness about the importance of properly securing loads to prevent crashes and injuries caused by flying debris. West Virginia, like other states, has laws in place to ensure that loads are secured to prevent them from falling off vehicles.

In West Virginia, a first offense for an unsecure load, resulting in an escaped load, carries a fine of \$250. Subsequent offenses within a 12-month period result in escalating fines: \$500 for the second offense and \$1,000 for a third offense, with potential permit revocation. A third offense can also result in jail time. Additionally, fines may vary depending on the specific nature of the violation and whether it resulted in physical injury.

"Many drivers think that only commercial vehicle drivers are responsible for securing their cargo," said Jack McNeely, director of the West Virginia Governor's Highway Safety Program. "We want our community to know that it is every driver's responsibility to ensure their load is properly secured to their vehicle to protect other vehicles, drivers, and bystanders," McNeely said.

From 2016 to 2020, an average of 16,878 people were injured per year when a vehicle collided with another object that was not properly secured. During this same period, an average of 732 people per year lost their lives. Non-commercial passenger vehicles accounted for 81 percent of these crashes, in which cargo was not properly secured.

In the rush of the day, it can be easy for drivers to overlook the importance of properly securing a vehicle's cargo. Before transporting a load, drivers should check that the vehicle's load is secured on the top, sides, and back, and make sure nothing can blow or fall out. Ensure the load is safe if the vehicle was to suddenly brake or hit a bump, or if the vehicle were to be hit by another vehicle. Drivers should ask: Would they feel safe driving behind the loaded vehicle?

Drivers should follow these tips to ensure properly secure cargo: Tie cargo down with rope, netting, or straps.

Tie large objects directly to the vehicle or trailer.

Consider covering the entire load with a sturdy tarp or netting. Don't overload the vehicle or trailer.

Always double-check the load to make sure it's secure.

# WVDOH Opens Southern Section of Berkeley Springs Bypass

The West Virginia Division of Highways (WVDOH) opened the 3.4-mile southern section of the four-lane US 522 Berkeley Springs Bypass in Morgan County on Wednesday, June 25, 2025.

State and local officials had long been concerned about heavy truck traffic on US 522 through the community of Berkeley Springs. About 30 percent of the approximately 13,400 vehicles that use US 522 every day are trucks.

"When completed, the bypass will provide for a more efficient route for commercial trucks, helping to ease longstanding congestion in the town of Berkeley Springs." said Transportation Secretary Stephen T. Rumbaugh, P.E.



In October 2020, Trumbull Corporation was awarded a contract for \$59.8 million to build the lower leg of a bypass around Berkeley Springs, beginning south of Winchester Grade Road and extending north of Martinsburg Road. The project included construction of several bridges, three new at-grade intersections, and a new interchange with existing WV 9 and Martinsburg Road.

"We are proud to deliver this critical infrastructure project as part of our ongoing commitment to modernizing West Virginia's roadways, promoting safety, and supporting our communities," Rumbaugh said.



In December 2022, A.L.L. Construction Inc. was awarded a contract for \$35 million to complete the northern leg of the bypass to connect the southern section back onto US 522 north of Berkeley Springs. That project also includes construction of two bridges and a connector road to War Memorial Hospital.

"The northern corridor of the Berkeley Springs Bypass remains under active development," Rumbaugh said. "Design work is advancing, and right-of-way acquisition is ongoing to prepare for future construction.

"We remain committed to moving this project forward and securing the resources necessary to complete the full bypass for the people of Morgan County," Rumbaugh said.

The northern section of the bypass is expected to open to traffic in 2027.


