1.0 INTRODUCTION

The Equipment Reporting System is the method employed by the Department of Transportation (DOT) to distribute all equipment related expenses to the responsible center and the authorization number for which equipment was used or assigned.

The Equipment Rental Rate is composed of all support expenses associated with owning, operating, and maintaining an equipment fleet. Specifically, expenses associated with repair parts, fuel and lubricants, mechanics' and related equipment, support staff payroll expenses and other expenses such as insurance, depreciation, etc. The rates are computed to distribute costs equitably. Further, the rate as developed provides a base rental rate applicable to the first forty hours of equipment ownership (use, idle or down) within a work week and an excess rental rate which is applied to the hours of use (only) in excess of forty within a work week.

All rental rates and reporting are on a per hour basis with each organization responsible for reporting the proper accounting distribution for utilized equipment.

The following Equipment Rate Listing is a complete classification of all equipment used within the operations of the Department of Transportation. This listing includes the general Classification, Description, Available Hours, Equipment Rental Rate and Excess Rate.
