We have reviewed the Phase IA archaeological technical report that was submitted for the above referenced project to determine potential effects to cultural resources. As required by Section 106 of the National Historic Preservation Act, as amended, and its implementing regulations, 36 CFR 800: "Protection of Historic Properties," we submit our comments.

According to submitted information, the WV Division of Highways proposes to modify existing WV 2 where it currently passes through the city of New Cumberland, Hancock County, WV. It is our understanding that specific design of a preferred has not yet been developed.

Archeological Resources:

According to the technical report, the Phase 1A archaeological constraints investigations covered a general study area comprised of all of the proposed alternatives with the exception of the four-lane bypass. It is our understanding that the majority of the study area is located on a floodplain along the east bank of the Ohio River. Although much of the floodplain surface has been disturbed by modern development, the potential for buried archaeological deposits is unknown. Therefore, geomorphological investigations were conducted in addition to the background research in order to assess the need for deep testing of various landforms within the study area. Portions of the study area were found to be disturbed, wet or steeply sloped, including the steep slopes along Ridge Avenue in the northern and southern portions of the study area, the channelized Hardin Run stream channel, the former Ohio River backchannel, disturbances on the upland landform, and disturbance in the area of the bridge over Hardin Run. No further archaeological investigation is recommended for these areas.

The remainder of the study area was divided into four test area: the Ohio Floodplain Test Area, the Fill/Floodplain Test Area, the Hardin Run Test Area and the Ridge Test Area. Intact soils were identified in each of these areas at varying depths and often below surface disturbance. The report makes recommendations for field investigations in each of the test areas depending upon where the preferred alternative is located. Within the Ohio Floodplain and Fill/Floodplain Test Areas, deep testing

is recommended beginning at the surface or at the base of any fill deposits. Methods used could include hand excavation of test units, mechanical excavation of trenches or a combination of both. Within the Hardin Run Test Area, recommendations are for the survey to investigate the modern ground surface to an approximate depth of 175.0 centimeters using a combination of shovel probe excavation with some form of deep testing. The report recommends shovel probe excavation for any portion of the preferred alternative that is located within the Ridge Test Area. We concur with the recommendations made and look forward to reviewing the Phase IB survey report once the preferred alternative have been selected.

Architectural Resources:

The submitted project materials do not address the proposed project's potential to affect architectural historic resources. We will provide comment upon receipt of this information

We have reviewed the information submitted for the abovementioned project to determine its effects to cultural resources. As required by Section 106 of the National Historic Preservation Act of 1966, as amended, its implementing regulations, 36 CFR 800: "Protection of Historic Properties," and West Virginia Code § 29-1-8, we submit our comments.

According to the submitted information, the West Virginia Division of Highways (WVDOT) is initiating NEPA studies for the WV Route 2, New Cumberland Project. The project proposes to upgrade WV Route 2 through New Cumberland by eliminating two 90 degree turns that make it difficult for large trucks to navigate the streets without running onto sidewalks. The first turn to be eliminated is located where WV Route 2 turns toward Madison Street and the Ohio River; the second turn is located at Madison and Chester Streets. As requested, we are providing your agency with our concerns.

Archaeological Resources:

A search of our records indicates that no previously documented archaeological resources are located within the general vicinity of the proposed project. However, given the nature of the terrain, there may be a potential for the proposed project to impact currently unknown archaeological sites. We will provide further comment once the Section 106 process has been initiated and project plans have been developed.

Architectural Resources:

Numerous previously identified architectural resources are located within close proximity to the proposed project intersections. Although none of these resources have been formally listed in the National Register of Historic Places, several of these resources, including, but not limited to, the Hancock County Courthouse (HK-0238); Union Soldier Monument (HK-1411); and the Pittsburgh, Cincinnati, Chicago & St. Louis Railroad (HK-1712), have been determined either individually eligible or as contributing resources to a potential New Cumberland Historic District. As project plans are developed, potential impacts to the built resources in the vicinity should be taken into consideration.

In order to evaluate the proposed project's direct and indirect impacts to architectural properties, we request you forward to our office color photographs and original dates of construction of all properties that are forty-five (45) years or older and will be directly impacted or will have a line-of-sight of the proposed project area, including tree cuts or relocation of above-ground infrastructure. Your photographs need to be keyed to a USGS topographic or

aerial map and should accurately depict from various angles any architectural resources, building or structural details, and outbuildings. Panoramic shots of surrounding landscapes and viewsheds are also necessary for us to complete our review. If nearby buildings or structures are less than forty-five (45) years old or will not be within the line-of-sight of the proposed project, please confirm in writing. We will provide additional comments upon receipt of the requested information; however, we reserve the right to request additional information, including the completion of Historic Property Inventory forms.

This is in response to your letter requesting threatened and endangered species information in regard to the proposed project listed above. These comments are provided pursuant to the Endangered Species Act (ESA) (87 Stat. 884, as amended; 16 U. S. C. 1531 *et seq.*).

Two federally listed species could occur in the project area: the endangered Indiana bat (*Myotis sodalis*) and the threatened northern long-eared bat (*Myotis septentrionalis*) (NLEB).

The Indiana bat and NLEB may use the project area for foraging and roosting between April 1 and November 15. Indiana bat summer foraging habitats are generally defined as riparian, bottomland, upland forest, and old fields or pastures with scattered trees. Roosting/maternity habitat consists primarily of live or dead hardwood tree species which have exfoliating bark that provides space for bats to roost between the bark and the bole of the tree. Tree cavities, crevices, splits, or hollow portions of tree boles and limbs also provide roost sites. In West Virginia, the U.S. Fish and Wildlife Service (Service) considers all forested habitat containing trees greater than or equal to 5 inches in diameter at breast height to be potentially suitable as summer roosting and foraging habitat for the Indiana bat.

Indiana bats feed on emerged aquatic and terrestrial flying. Moths, caddisflies, flies, mosquitoes, and midges are major prey items. Aquatic insects that have concentrated emergences or that form large mating aggregations above or near water appear to be preferred prey items. As a result, streams, wetlands, and associated riparian forests are often preferred foraging habitats for pregnant and lactating Indiana bats. Indiana bats also forage within the canopy of upland forests, over clearings with early successional vegetation (e.g., old fields), along the borders of croplands, along wooded fencerows, and over farm ponds in pastures. Increased erosion and sedimentation of streams reduces diversity and biomass of benthic invertebrates, i.e. insects. Some projects propose impacts to aquatic features such as streams or wetlands, which could result in a decrease in insects available to both bat species for foraging.

Updated June 2017

Similar to the Indiana bat, NLEB foraging habitat includes forested hillsides and ridges, and small ponds or streams. NLEB are typically associated with large tracts of mature, upland forests with more canopy cover than is preferred by Indiana bats. NLEB seem to be flexible in selecting roosts. They choose roost trees based on suitability to retain bark or provide cavities or crevices, and this species is known to use a wider variety of roost types than the Indiana bat. Males and non-reproductive females may also roost in cooler places like caves and mines. Although rare, this bat has also been found roosting in structures like barns and sheds.

Indiana bats and NLEB use caves or mine portals for winter hibernation between November 15 and March 31. These species also use the hibernacula and the areas around them for fall-swarming and spring-staging activity (August 15 to November 14 and April 1 to May 14, respectively). Some males have been known to stay close to the hibernacula during the summer and may use the hibernacula as summer roosts. There may be other landscape features being used as hibernacula by NLEB during the winter that have yet to be documented.

The Service has reviewed the number of acres of potentially suitable foraging and roosting habitat on the West Virginia landscape available to each Indiana bat, versus the total acreage of forest. On that basis, we have determined that small projects, more than 10 miles from a known priority 1 or 2 Indiana bat hibernaculum, more than 5 miles from a known priority 3 or 4 Indiana bat hibernaculum, or more than 2.5 miles from any known maternity roost, or more than 5 miles from summer detection sites where no roosts were identified, that affect less than 17 acres of forested habitat, and will not affect any potential hibernacula, will have a very small chance of resulting in direct or indirect effects to the Indiana bat, and therefore these effects are considered discountable. **Please note that the Service may review and update this assessment at any time as new information becomes available.**

The Service has determined that this project is not likely to adversely affect the Indiana bat because your project: 1) will affect less than 17 acres of potential Indiana bat foraging or roosting habitat; 2) is not within any of the Indiana bat hibernacula or summer use buffers described above; 3) will not affect any potential caves or mines that could be used as hibernacula for this species; and 4) effects to aquatic features used for foraging habitat will be insignificant.

The NLEB may occur within the range of the proposed project, and may be affected by the proposed construction and operation of this project. Any take of NLEB occurring in conjunction with these activities that complies with the conservation measures (as outlined in the 4(d) rule), as necessary, is exempted from section 9 prohibitions by the 4(d) rule and does not require site specific incidental take authorization. Note that the 4(d) rule does not exempt take that may occur as a result of adverse effects to hibernacula and that no conservation measures are required as part of the 4(d) rule unless the proposed project: 1) involves tree removal within 0.25 miles of known NLEB hibernacula; or 2) cuts or destroys known, occupied maternity roost trees or any other trees within a 150-foot radius around known, occupied maternity tree during the pup season (June 1 to July 31). This proposed project is not located within any of these radii around known hibernacula or roost trees and will not affect any known NLEB hibernacula, therefore any take of NLEB associated with this project is exempted under the 4(d) rule and no conservation measures are required.

Should project plans change or amendments be proposed that we have not considered in your proposed action, or if additional information on listed and proposed species becomes available, or if new species become listed or critical habitat is designated, this assessment may be reconsidered.

We have reviewed the report titled *Historic Architectural Resource Survey and Determination of Effects Report WV 2 Improvements – New Cumberland, Madison Street and Chester Street Intersection and Widening, City of New Cumberland, Hancock County, West Virginia* that was prepared for the above-referenced project. As required by Section 106 of the National Historic Preservation Act of 1966, as amended, and its implementing regulations, 36 CFR § 800: "Protection of Historic Properties," we submit our comments.

Based on the submitted documentation, we concur with the consultant that the following resources lack the integrity and significance to be individually eligible for or contribute to a historic district eligible for or listed in the National Register of Historic Places: 916 S. Chestnut Street (HK-1426); 924 S. Chestnut Street (HK-1427); 928 S. Chestnut Street (HK-1428); 932 S. Chestnut Street (HK-1429); 935 S. Chestnut Street (HK-1430); 940 S. Chestnut Street (HK-1431); and 1022 S. Chestnut Street (HK-1432). We also concur with the consultant that Alternatives 1, 3, and 5A will result in adverse effects to built resources eligible for or listed in the National Register. Alternatives 2 and 4 will not directly impact any resources eligible for or listed in the National Register.

If Alternatives 1, 3, or 5A are chosen, we request you evaluate alternatives or modifications to the proposed project to *avoid, minimize, or mitigate* the adverse effects the selected alternative will have to historic properties and then inform our office of those alternatives or modifications. As instructed in 36 CFR 800.6(a), as you know it is also your office's responsibility to notify the Advisory Council on Historic Preservation (ACHP) of our assessment of *adverse effect* if one of these three alternatives is chosen. We will provide additional comments upon receipt of the requested information.




