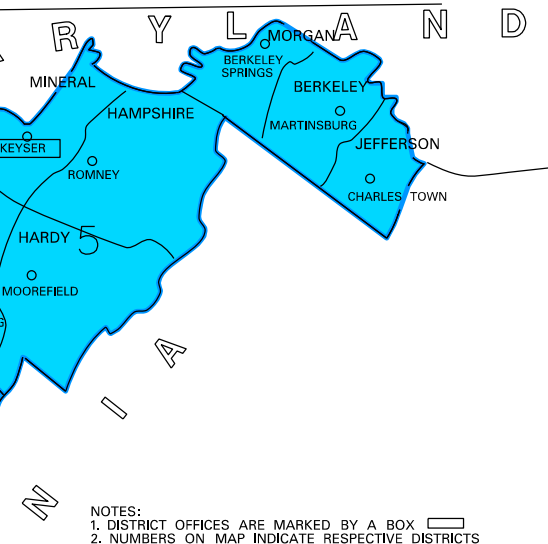

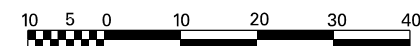

SCALE OF MILES

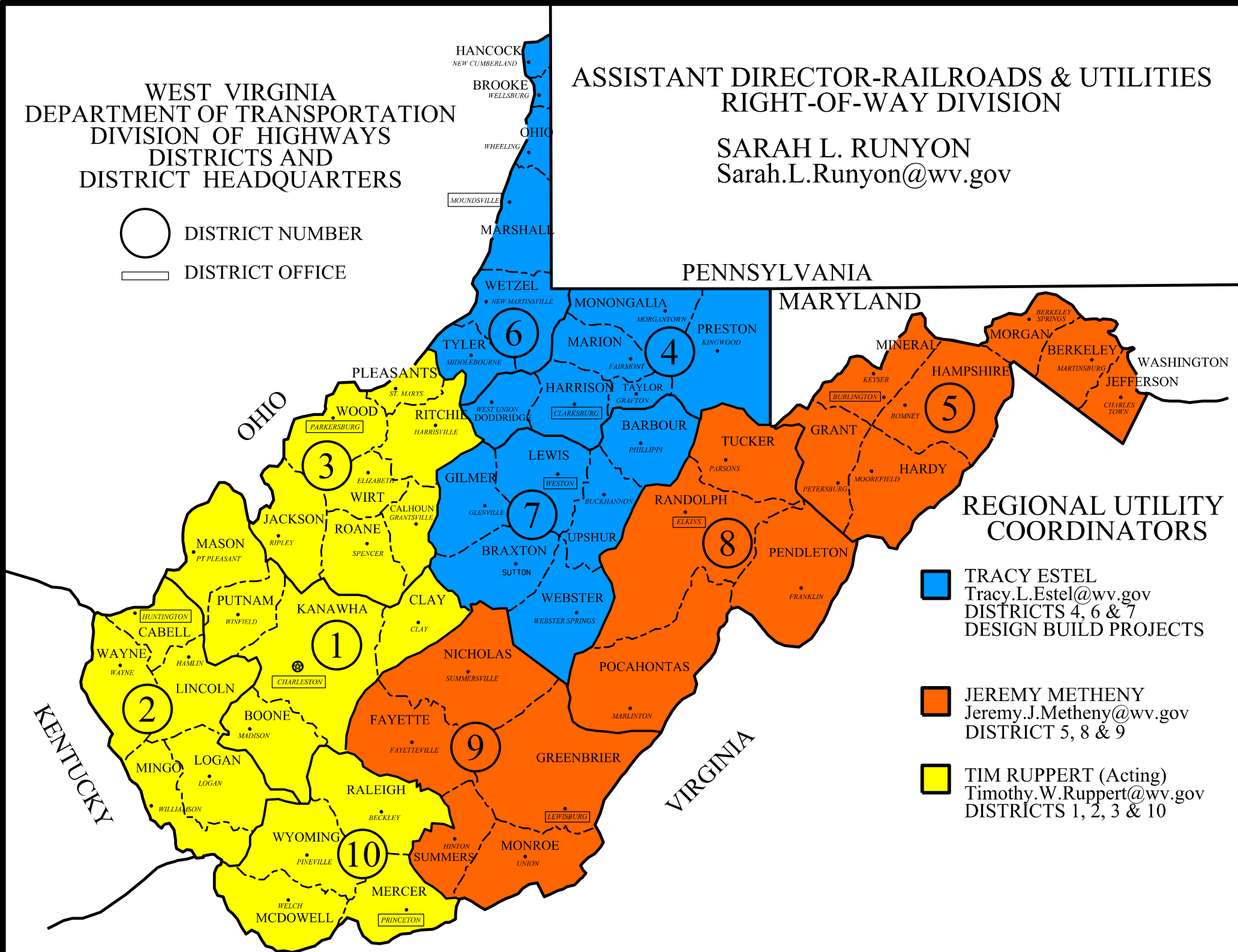
