**PURCHASING AFFIDAVIT**

**MANDATE:** Under W. Va. 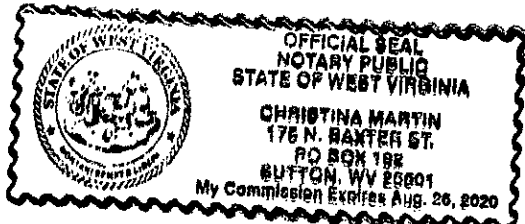


