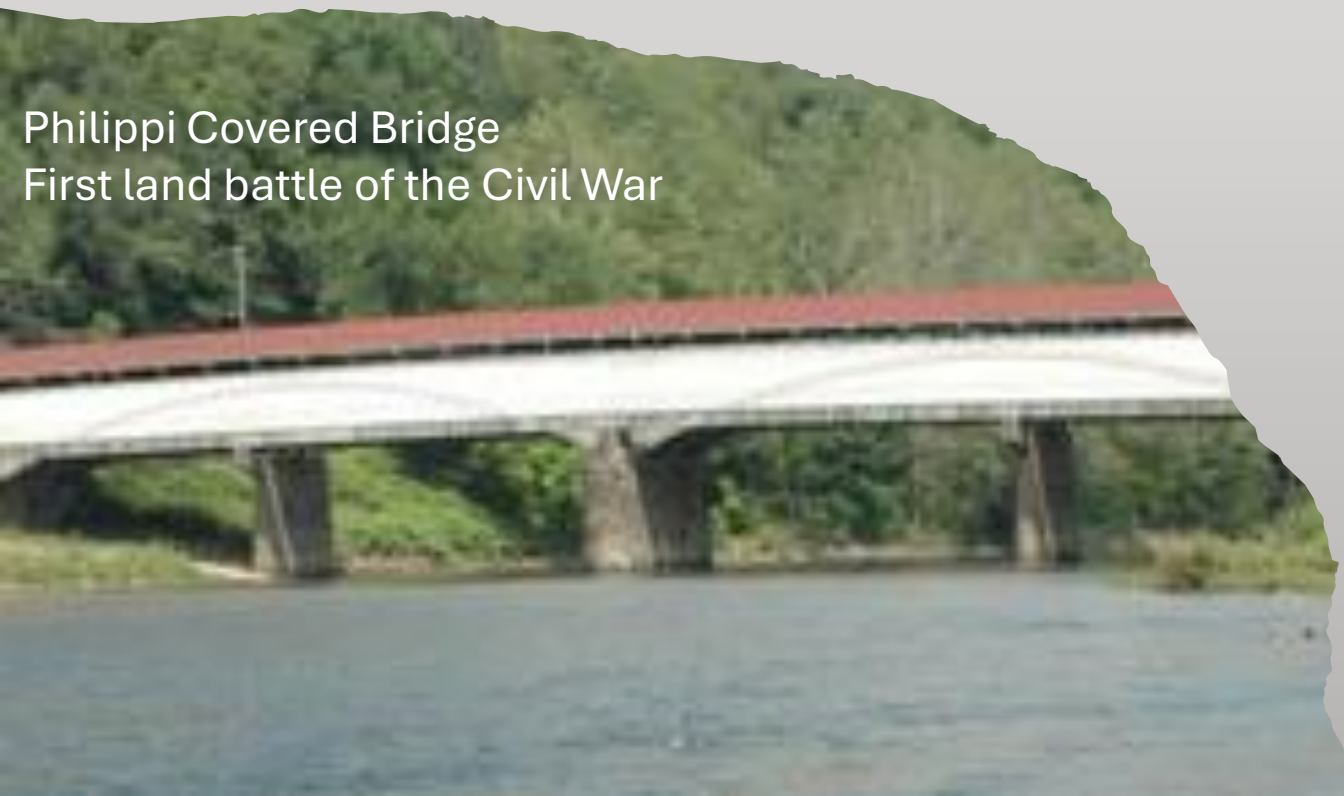
Changes to the Certifications

- 5-year certification
- Require an apprenticeship
- PCC Inspector required as prerequisite for PCC Technician
- Only 1 chance to pass Practical
- Include an Ethics presentation in all classes now
- Include an AASHTOWare Project (AWP) presentation in all classes now
- Extending certifications 1 year for instructors
- Adding a Code of Conduct to MP 106.03.50 for certification classes

Apprenticeship Requirements

- Pass written exam
- Pass hands-on practical exam
- Documented hands-on experience (Minimum 40 hours)
- Also required for reciprocity
- Does not apply to applicants whose certification expired
- Worklog must be submitted and approved BEFORE registering for the Practical Exam for Soil and Aggregate Compaction and Aggregate Technician
- Asphalt Field, Asphalt Plant, and PCC Inspector may submit the worklog after the Practical Exam

21.3. CODE OF CONDUCT

- 21.3.1. The purpose of this Code of Conduct establishes expectations for behavior throughout the training course and during the end-of-course written exam. Its goal is to create a respectful productive, and fair learning environment for all participants.
