 - o Approval will state it meets necessary specification similar to ST-1
- Will materials be categorized?
 - o Yes, there will be general categories and organization, up to purchase order people to make decisions on whether use it or not
 - Working with procurement division on language involving current specifications and OPOM
 - o QPOM list will state what the product does with clear expectation

- o AASHTO Product Evaluations and Audit Solutions does not approve materials, they test products and then materials compares to their standards
- There could be products on QPOM list that are not AASHTO Product Evaluations and Audit Solutions tested, they will need to be tested by materials division or possible third party
- Point of the QPOM list is to make purchase order process simpler and tested
- Attempting to make fair opportunity to allow all companies and products the chance to make it on the list
