(Present for all Meetings) Two specification changes updating Section 642-Temporary Pollution Control: 1. Section 642.6-Silt Fence • Specification adds three grades of silt fence. This is based on a range of products on the WVDOT Approved Products List. Recommended in the specification are Temporary, Standard, and High Performance. The differences are strength and UV stability. Temporary silt fence will be adequate for projects that can be completed in a single construction season. Standard silt fence will be used for projects that last two seasons. High Performance silt fence will be used for longer projects, and in challenging situations such as shallow concentrated flow that are likely to overstress standard silt fence.
