**WHEREAS**, Chapter 17, Article 2A, Section 4, of the Official Code of West Virginia, 1931, as amended, authorizes the Commissioner of Highways to be in charge of the selection and the effective organization of all West Virginia Division of Highways personnel; and

**WHEREAS**, Chapter 17, Article 2A, Section 8, of the Official Code of West Virginia, 1931, as amended, authorizes the Commissioner of Highways to promulgate rules for the efficient administration of the State road program; and

**WHEREAS**, to provide for the proper and efficient transaction of business within the West Virginia Division of Highways, certain revisions to the present organizational structure are necessary and prudent;

**NOW, THEREFORE, BE IT ORDERED** that the Commissioner's Order, dated August 1, 2023, implementing the Organization Chart of the same date, pertaining to the organizational structure of the Division of Highways, be amended and


**BE IT FURTHER ORDERED** that the attached West Virginia Division of Highways Organization Chart, dated January 9, 2024, supersedes all previous organization charts and is hereby established and will take effect January 9, 2024.

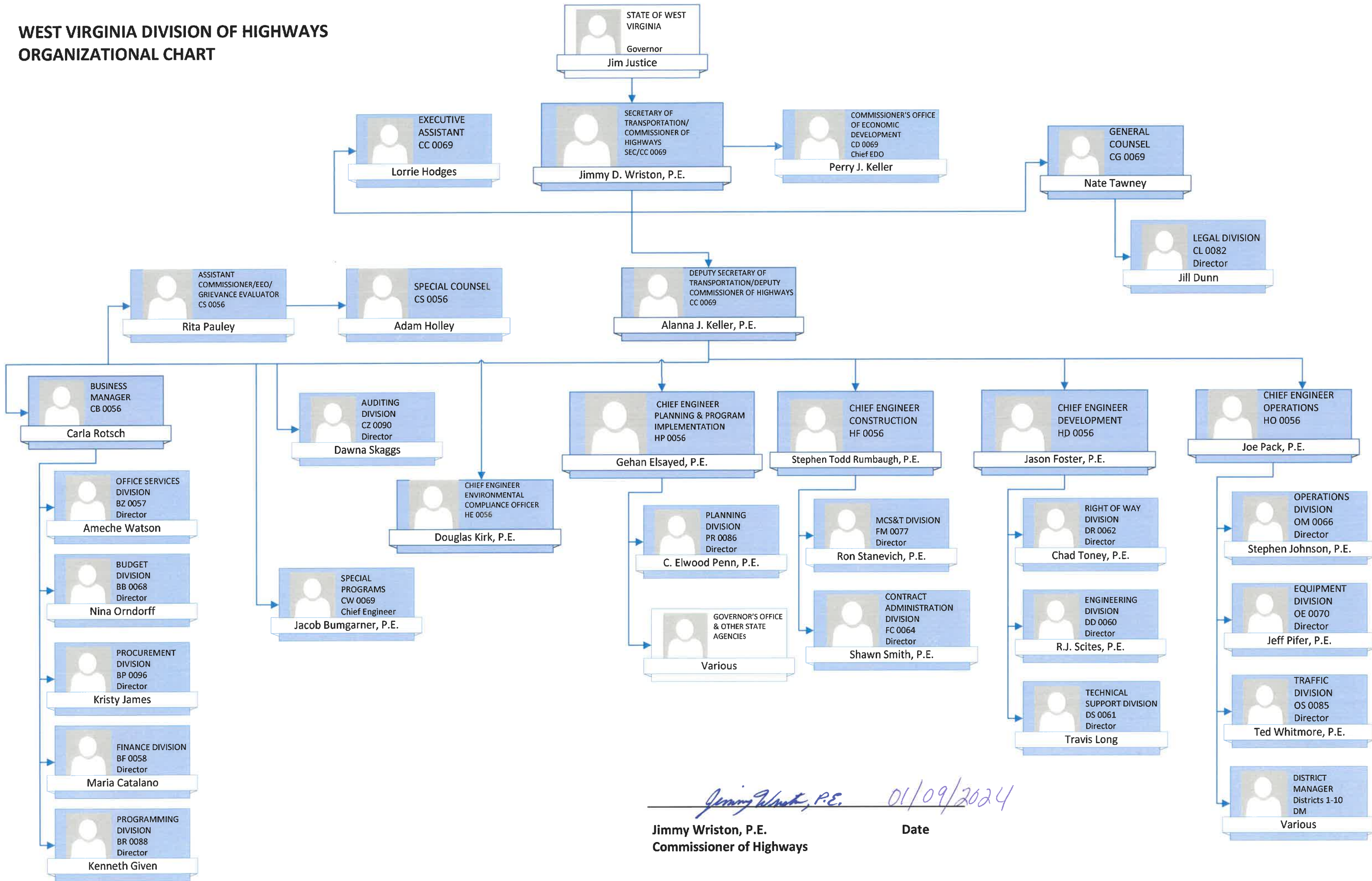
