SCOPE OF WORK

Wycliffe Technologies Inc. is providing this pricing based on the Project Site Map as well as information received on the mandatory walk through and the Instructions to Vendors Submitting Bids dated 1/9/2020, received from the West Virginia Department of Highways on November 30, 2020. Wycliffe Technologies will provide all labor, tools, material, and supervision for the following scopes within Division 28 (Security). BICSI and TIA/EIA Standards apply.

Security Camera Installation

Install fifteen (15) new Security Cameras, three (3) Security Data Switches & one (1) Security Server at the West Virginia Department of Highways Equipment Depot. Install, terminate, label & test the cabling infrastructure and install the conduit for the fifteen (15) new Security Cameras. Provide the demolition of the existing cameras, cabling infrastructure and conduit.

Horizontal CAT6 and Outside Plant (OSP) CAT6 Cabling for Security Cameras, Installation and Alignment of new Security Cameras and Demolition of Existing Security Camera System

- **1. Horizontal CAT6 and OSP CAT6 Cabling** Wycliffe Technologies, Inc. (hereafter referred to as WT) will provide and install a CAT6 Cable Plant including Rigid Conduit, Intermediate Distribution Frame (IDF) Enclosures, Cable, Jacks, Biscuit Jack Enclosures, Patch Panels, Wire Management, Labeling, Terminations and Testing. TERMS & CONDITIONS

TERMS AND CONDITIONS FOR SALES AND SERVICES

In consideration of the mutual promises and covenants hereinafter specified, and for other good and valuable consideration, the parties hereto do, for themselves, their successors and assigns mutually agree as follows:

1. ORDER ACCEPTANCE

These terms and conditions apply to all Customer orders for systems sales and services offered by; Wycliffe Technologies which include, but are not limited to, CCTV, access control, intercoms, alarms, Code Alert, detection systems, identification systems, and/or other related systems. The customer wishes to contract with to provide these products and services on either an "on call" or contract basis to the Customer's various systems.

2. PEVIOUS AND NEW INSTALLATIONS

Customer hereby represents that it has contracted or may contract with for the installation of an electronic security systems or other services or products or associated equipment at one or more premises owned or occupied by the Customer; and that the Customer may desire additional continued services for the above. Upon receipt of a Customer purchase order, a coordinator will be in contact with the Customer to schedule a mutually agreeable time for any services, which could include the installation of new systems or components.

3. DELIVERY OF DIRECT SALE Equipment Services may include the direct sale of equipment or replacement parts. Dates quoted for equipment are approximate and are based upon proper receipt of all necessary information, documents, and materials that are required to be furnished by Customer.

Delivery of products will be by UPS ground unless otherwise specified. Overnight or other special delivery will be made at added charge to Customer. All sales are F.O.B. Manufacturer's shipping point unless otherwise specified on Customer's purchase order. shall not be responsible for any delays or defaults hereunder by reason of fire, flood, acts of God, labor troubles, inability to secure materials, acts of government or other causes beyond 's reasonable control.

4. PRICES, PAYMENTS, TAXES; CHARGES

Standard WT's payment terms are as follows:

Except as provided below, all contracted services require payment in full, due upon receipt of invoice.

Installation contracts or services in excess of \$5000 in charges require - A.) 30% down payment. B.) 100% payment of stored materials upon receipt at WT's warehouse. Inspection of billed products by Customer at WT's warehouse will be permitted. C.) Progress labor billing will occur each month based upon the percentage of completion of whole project up to 90% of total labor charges. D.) Final charges will be billed upon final completion of the job. All billings shall be net due upon receipt of invoice.

Customer is responsible for all taxes; except if the Customer represents that it is tax exempt under sections 501(a) and 501(c) of the Internal Revenue Code of the United States, and under the applicable laws of any State due any tax. If Customer represents that all sales, use or business taxes or personal property taxes and all fees imposed by municipal, state, and/or federal authorities in connection with the systems and services to be performed or sold by are tax exempt. Customer agrees to hold harmless from and to indemnify against any of the foregoing charges if the exempt status is incorrect, discontinued, or modified.

5. CONSTRUCTION AND REMEDIES

The contract shall be deemed to have been entered into and shall be construed and interpreted in accordance with the UNIFORM COMMERCIAL CODE of the State of Maryland. The illegality of any particular provision or provisions of this agreement shall not affect the remaining obligations of the Customer or of as set forth herein. Waiver by of a breach by customer of any provisions of this agreement shall not be deemed a waiver of future compliance therewith and such provision, as well as other provisions hereunder shall remain in full force and effect. The parties' consent to exclusive jurisdiction as to all disputes between them in the courts of the State of Maryland. Finance charges shall accrue at the rate of 2% per month if not paid when due, or the maximum rates allowed by law. shall recover its courts costs and attorney's fees in enforcing its rights hereunder.

6. INSTALLATION/ SERVICE LABOR

All contract work will be calculated at standard billing rates in effect as of the date of any work performed on a per-man per-hour basis for the estimated hours to complete the project. WT reserves the right to bill for the full charges in excess of the estimate. Time and material services or installation charges will be at 's standard rates in effect as of the date the services are provided. Saturday and overtime rates will



be charged at time and one-half of 'S standard rates; Sundays and Holidays will be charged at two times 's standard labor billing rates. Other incidental charges such as tolls, travel, hotels, etc. as applicable, will be added to invoices.

7. WARRANTY
