- 6.5.2 Force Majeure: It shall be further noted that the Vendor is not responsible for and shall not be penalized for delays in its delivery when caused by factors or events outside Vendor's control, including but not limited to acts or omissions of the Agency or third parties, acts of civil or military authority, civil disturbance, war, terrorism, pandemics, explosions, fire, floods, tornadoes, or other natural disasters or Acts of God. - 4.8.1 Price adjustments will only be considered annually at the contract renewal, and only if WVDOH and the renewing vendor agrees to renew the contract for another year under the same terms, conditions, and specifications.
- 4.8.2 Contract Items 1 through 40 will be adjusted proportionally, upwards, or downwards, based on the percentage change from January 1, of the year of the initial contract award to January 1 of the year of the renewing contract in the FRED Economic Data, Producer Price Index by Industry for Cement and Concrete Products Manufacturing at https://fred.stlouisfed.org/series/PCU32733273.

#### EXAMPLE:

- The January 2021 index rate was 179.800
- The January 2022 index rate was 197.724
- The bid price for Contract Item 1, at the time of bid: \$100 CY

A 9.97% increase in the Cement and Concrete Products Manufacturing index occurred between January 2021 and January 2022. Contract Item 1 will be adjusted proportionally to match the percentage change in the index – therefore will be increased by 9.7%. The contract price for this Contract Item during the renewal period will be adjusted to \$109.97.

- **4.8.3** Contract Items not specified within this section are not eligible for price adjustments.
- **4.8.4** Price adjustments shall be memorialized by a written Change Order which much be reviewed and approved by the WVDOT Budget and Procurement Division to be effective. Adjusted pricing will not take effect until the effective date of such Change Order and cannot be retroactive.

The WVDOH shall, at its sole discretion, decide if a proposed "equal to" is an acceptable equivalent to the product brand being bid. The Agency may contact the Vendor if more information is needed to determine equivalency. Failure to provide requested information within 10 calendar days of the Agency's request shall result in the disqualification of the "equal to" product bid.

- Operations Division will announce the effective date of use of this contract to the Districts and the Vendors, whether it is by the effective date, the completed and encumbered date, or an established date by the WVDOH. Upon the announced effective date of use, any order issued prior to the award of the contract shall remain in effect and should not be cancelled until that order is filled; however, after 10 working days of the Districts and Vendors notice, any order that has not been completely filled by the Vendors shall NOT be completed and a cancellation notice will be sent to that Vendor from the issuing District for cancellation of the balance of that order only. No orders from prior contracts should be held open by the Districts or Vendors longer than 10 working days after the effective date of use is announced for the new contract.
- **4.6 Cooperative Contracting:** The purchase prices on all Contract Items herein, available for the WVDOH, shall be adoptable for other public agencies upon their request. Agencies under the authority of the West Virginia Purchasing Division must receive prior approval by the Purchasing Director.
- 4.7 Price Adjustment of Fuel Oil No. 2 (Diesel Fuel): Due to the uncertainty in estimating the cost of diesel fuel that will be used during the life of this contract, adjustment in compensation for applicable items shall be per Standard Specs 109.9, as amended, with the exception that Factor "C" in the Price Adjustment for Fuel formula is to be broken down by component, as shown in Figure 4.7.A.

The Price Adjustment for Fuel formula to be utilized for this contract is:

Failure to provide the source plant location on ATT A will result in the disqualification of the bid. Vendor shall mark with an "X" the counties that correspond with the source plant bid prices on this page. If Vendor has varied pricing per county or plant, Vendor shall complete a separate set of ATT A for each county/plant pricing set.
- 4.2.2 Vendor should type or electronically enter the information into the Pricing Pages spreadsheet to prevent errors in the evaluation. - 4.2.3 Changing a column or row description, Contract Item description, or unit of measure on the ATT A, shall result in the disqualification of Contract Item bid on the altered line. Submitting Pricing Pages other than those provided with this solicitation, as described within this section, shall result in the disqualification of Vendor's bid in its entirety. Vendor entries of bid prices or other notations made in wvOASIS commodity line descriptions will not be considered for bid evaluation or award.
- 4.3 Source Plant Location, ATT B: Vendor shall complete ATT B, in its entirety, including information for all source plants bid on ATT A and shall list the MSC&T approved plant code. Failure to complete and submit ATT B with bid submission will result in the disqualification of the entire bid.
- 4.4 "Equal To" Proposals, ATT C: Vendor shall complete ATT C in its entirety if bidding an "equal to" item and attach any supporting documentation to support that the proposed item is equivalent. If Vendor fails to submit ATT C with their bid it will be assumed that the brand specified in Section 3.2.7 is the product brand being bid.

CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder.
